LEADERSHIP IN URBAN MOVEMENTS

Brief Course Description

This is a 3-unit course. It focuses on the social change philosophy, principles, strategies associated with social movements in general and among urban poor in particular and how leadership is developed and sustained in these movements. It then helps students derive biblical insights on the lessons of social movement organizing and leadership development and derive implications for their ministry of facilitating social transformation in urban communities.

Course Objectives

At the end of the course, students would have:

- Gained understanding of the nature, principles, and dynamics of social movement in general and among urban poor in particular, as a strategy for transformative change. This will be evident in being able to articulate those learnings.
- Gained understanding of processes and principles of leadership development in social movements as
 evident in being able to articulate them and /or apply learnings in analyzing selected cases
- Derived biblical insights on the above learnings and reflected as to what will be the most appropriate
 Christian response to social movements of the poor and to the quality of leadership formed out of these
 movements. The implications of such response to our concept of spirituality, theology of service and
 transformation and life and politics of our churches will be explored.

On the whole, this course is intended to further equip students for transformative urban ministry especially in the area of dealing with power issues.
